If you want to qualify for authorization, you must purchase 60000 boxes in the first 12 months.

According to the "Trademark Law" and the "Implementation Regulations", the two parties signed this contract for the sale of NAGARAKU eyelash and eyelash tools through friendly negotiation, following the principles of voluntariness and faith.

Scope of trademark authorization:

I. The licensor authorizes licensee to be the product agent of NAGARAKU, the agent products are: NAGARAKU **Nagaraku Classic and Nagaraku New Material**

II. Trademark logo: (attached page)

III. The term of licensed use starts from date: **2nd November, 2023** to date **1nd November, 2024**

When the contract expires, if the authorization time needs to be extended, the licensor and licensee shall renew the trademark license contract.

IV. The range of use NAGARAKU products as following:

Selling NAGARAKU products in **Europe and UK market, through the website <https://naturallashes.eu>**
(Note: Amazon, AliExpress, Shopee, Alibaba, 1688, Taobao, Pinduoduo, eBay, Wish, Lazada, Wal-Mart are not allowed)

V. Rights and obligations of both parties:

1. Rights and obligations of licensor:

1.1. The licensor has the right to adjust the product structure, price and sales policy according to the dynamics of the market competition.

1.2. The licensor must provides products with good quality to licensee.

2. Rights and obligations of licensee:

2.1. The licensee should recommend products to users and maintain the reputation of NAGARAKU company and products; the licensee shall not slander the reputation of licensor's company and products in any form. If the licensee is found to have slandered the reputation of licensor and its products, the licensor has the right to terminate the cooperation agreement and reserves the right to pursue legal responsibility.

2.2. The licensee shall cooperate with licensor's market promotion, industry promotion and promotion activities, and strive to develop the new market.

2.3. The licensee is supposed to purchase at least **10000 trays** per month.

2.4. The licensee is allowed to use the NAGARAKU trademark in the products sale, quotation, advertisement and promotion.

VI. Return and exchange products:

1. The licensee must inspect the goods within three days after receiving the goods. If the product is damaged, it must notify the licensor in writing, otherwise it will be regarded as a qualified inspection. The date of receipt of the goods is subject to the date of actually delivery.

2. If you need to return or exchange the goods, it must be carried out within 10 days of receiving the goods. If it exceeds 10 days, the return and exchange business will no longer be accepted. The licensee shall bear the return freight for non-quality problems.

VII. The non-compliance party has the right to claim financial compensation to the breaching party for losses caused by one party's failure to perform its obligations under the contract or a serious breach of the contract's provisions. The two parties reach a consensus through negotiation, and the contract can continue to be performed after the observant party receives compensation.

VIII. If the contract dispute cannot reach a consensus, the dispute can be submitted to the China Council for the Promotion of International Trade Arbitration Commission for arbitration. The arbitration result is final and binding on both parties.

IX. This agreement is in duplicate, each party holds one copy.

Once you are found to be selling fake NAGARAKU goods, the cooperation will be terminated and the legal responsibility will be investigated.
